OFFICE ORDER

Sub: Matter regarding the students who after getting enrolled in their respective M.Tech./M.Plan./Ph.D. programs with "Institute Scholarship", withdraw from the program in the Mid-way.

As per the decision taken by the Senate in its 32nd Meeting (Item No 32-3.8) held on 28th March 2015, the following guidelines shall be applicable in respect of the students who after getting enrolled in their respective M.Tech./M.Plan./Ph.D. programs with "Institute Scholarship", withdraw from the program in the Mid-way (i.e. without its successful completion).

- (i) "Institute Caution Money" shall be refunded to a Undergraduate/Postgraduate/Ph.D. student only on his/her successful completion of the enrolled program.
- (ii) Only those students who complete the programme shall be eligible to get "Character Certificate" and "Migration Certificate" from the institute on demand.
- (iii) All the students who enroll in their respective P.G./Ph.D. programmes with Institute Assistantship shall have to submit an "undertaking" as stipulated on a prescribed format (on a non-judicial stamp paper of Rs. 50/- duly signed by a Notary).
