- d. Applications received after the due date will be summarily rejected.
- e. All qualifications, experience and age limit will be considered as on 28th December 2023
- f. All degrees mentioned in the application should have been awarded by an Institute/University recognized by the Sate/ Central Government/other Statutory Bodies.
- g. As an Institute of National Importance, IIIT DHARWAD, strives to have a workforce which reflects all India character and hence candidates from all over the country are encouraged to apply.
- h. Candidates serving in Govt./Semi Govt./Autonomous/PSUs/Educational Institutes, should send their applications either THROUGH PROPER CHANNEL or should furnish a NO OBJECTION CERTIFICATE (NOC) from the Competent Authority of the Organization serving, at the time of interview.
