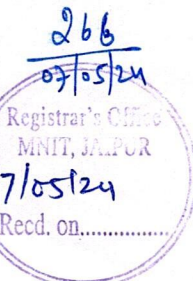

Applications are invited for filling up of vacancy to the post of Director in the National Institute of Technology (NIT), Srinagar (Jammu & Kashmir). NIT, Srinagar (J&K) is Centrally Funded Technical Autonomous Institute of the Ministry of Education, Government of India functioning in the country as an 'Institution of National Importance' governed by the National Institutes of Technology, Science Education and Research (NITSER) Act, 2007 (29 of 2007).

The Director, being the academic as well as administrative head, is expected to be:

- A visionary with proven leadership qualities, administrative capabilities as well as teaching and research credentials.
- Having Ph.D. degree with first class degree at Bachelor's and Master's level in Engineering / Technology. In case of candidates who have obtained Ph.D. directly after B.E. / B.Tech., they should have obtained 1st class at Bachelor's level in Engineering / Technology.
- The candidate shall be an eminent person in his / her field of specialisation with an outstanding academic record throughout.
- The candidate shall have 15 years' experience in Teaching / Industry / Research out of which 10 years must be at the level of Professor or above in a reputed educational Institute, Industry, Research Organisations.
- Preferably not more than 65 years of age as on the closing date of receipt of applications of this advertisement.

Salary and Service Conditions:

- The post carries a pay of Rs.2,10,000/- (Fixed) per month with Special Allowance of Rs.11,250/- and other usual allowances.
- The terms and conditions of the services will be those as set forth in the Act, Statutes and Ordinances of the Institute.

- Appointment will be made from a panel of names recommended by a Committee constituted under the provisions of NITSER Act, 2007 and Statutes framed under the Act.

- Candidates are mandatorily required to upload the 'No Objection Certificate (NoC)' on the recruitment portal. The NoC should be in the prescribed format only and duly verified by the Head of the Institution / Organisation / present & principal employer.
- The last date of uploading duly verified NoC on the portal is 10.05.2024.
- Application once submitted cannot be altered / resubmitted, under any circumstances. Further, no request with respect to making changes in any data / particular entered by the candidate in the Online Application will be entertained, once the application is submitted successfully.
